RESOLVED that the Minutes of the 15th Management Meeting held on 1. 22.03.2023 are unanimously confirmed and approved.

**RESOLVED** that the expenditure for the month of Feb. 23 and March 23, 2. Rs.8,49,892/- (Eight lac forty nine thousand eight hundred ninety two only) and Rs.7,13,366/- (Seven Lac Thirteen Thousand Three Hundred and Sixty Six Lac) respectively are approved. Further resolved that the receipts for the month of Feb. 23 and March 23as Rs.21,37,293/- (Twenty One Lac, Thirty Seven Thousand Two Hundred Ninety Three Only) and Rs.2,84,281/- (Two Lac Eighty Four Thousand Two Hundred Eight One Only) respectively are approved.

RESOLVED that the expenditure of Rs.68,355/-(Sixty eight thousand 3. three fifty five thousand only) incurred in connection of Holi Festival is approved. The expenditure is within the sanctioned amount of Rs.80,000/-(Eighty thousand only). **DELIBERATION OF RWH: - RESOLVED** that an Estimate of amount 4. Rs.45,00,000/- (Forty five lac only) for installation of RWH System in the society was approved vide resolution NO.9 (F) of the 6<sup>th</sup> MC Meeting dated 25.09.2022. The estimate was prepared for 200.06 M3 rain water of roof-top and surface area in society.

The work of s/fixing PVC pipe line and digging / excavation of recharge chamber was started on 20.01.2023. Meanwhile a group of members objected the digging in the central lawn on the pretext of possible damage to the property and harm to their life and forced the MC to stop the work.

The public notification of DJB dated 14.02.2023 has changed the guidelines of the installation of RWH System and restricted the society to use only rooftop rain water for the system. As such the whole process of installation of the system is to be revised. Meanwhile Mr. D.C. Goel, Flat No.111, has offered on social media (whatsapp), to provide the design for RWH System at the rate Rs.3,000/- (Three thousand only) per Flat. Accordingly he

has been asked to submit the above-said economical design of RWH so that the society can be benefited.

The agency M/S Rudra Associates has submitted a bill on 29.03.2023 of Rs.9,89,088/- (Nine lac eighty nine thousand and eighty eight only) for the work done till that dated. The measurements of the work done / bill has been jointly checked in the society by Mr. S.N. Behera, Flat No. 137, Mr. K.V. Mohan Rao flat No.91 and the society Manager, Mr. Rakesh Kumar along with contractor. It has been decided unanimously to pay 70% (Approximate) of the bill amount.
