### MINUTES OF THE MEETING.

<sup>21st</sup> Management Committee meeting has been held on 24<sup>th</sup> September 2023 at 12.00 P.M. in the meeting room of society. The following Hony. Members attended the meeting and were present to deliberate & take final decision.

- 1. Resolved that the minutes of last management committee meeting held on 08.09.2023 is unanimously confirmed & approved. Moreover the next date of hearing at R.C.S office is on 26.09.2023. The three arbitration cases under section 70 in the court of Dy. Registrar are pending in the court & next date of hearing are as under-
- (i) Mr. Mohan Advani V/s. Nav Nirman Cooperative G/H. Society Ltd. is on 5,12,2023
- (ii) Mrs. Madhulika Goel V/s. Nav Nirman Cooperative G/H. Society Ltd. is on 05.12.2023
- (iii) Mr. Vishva Raj Vishnoi V/s. Nav Nirman Cooperative G/H. Society Ltd. is on 04.10.23
- 2. Resolved that the receipt for the month of May, June , July & August 2023 are Rs. 14,54,454/- Rs. 7,76,079/- Rs, 2,33,652/- and Rs. 92,042/- respectively are confirmed approved moreover the expenditure for the month of May, June, July and August 2023 are Rs. 3,41706, Rs. 5,08,797/- Rs. 4,62,034/- and Rs. 4,29,936/- respectively are confirmed & approved.
- 3. Resolved that the Audit Report and Balance Sheet for the financial year 2022-2023 has been deliberated in the meeting and the audit report and Balance sheet is approved. Moreover the Auditor should file the audit report and Balance sheet in the I.TAX Department and society will deposit it in the R.C.S office and it is approved.
- 4. Resolved that as per resolution No. 4 of the G.B.M. held on 15.01.2023, demand letter be issued to the members for Rs. 10,000/- as 2<sup>nd</sup> instalment of maintenance fund to be paid by 31.10.2023. Moreover defaulter should be issued demand notice accordingly to resolution No. 7 of G.B.M. dated 07.04.2002. Resolution No. 7 is hereby reproduced below." Resolved that

member ,who have not paid last two maintenance fund 1999-2000, 2000-2001or more instalment to the society, the following services will be stopped or discontinued w.e.f 01.05.2002.

- 1. Water supply through O.H. Tank.
- 2. Ban on entry of members tenant in the gate.
- 3. Discontinue the dak distribution.
- 4. Ban on allotment of lawn club building for function.
- 5. Disconnect the cable T.V.
- 6. Discontinue services of electrician, plumber, sewer man and security guard etc.

Moreover similar resolution's were passed in G.B.M held on 25.01.2004, (Resolution No. 6) and in G.B.M. held on 07.05.2006(resolution No. 6) were passed.

Resolved that the action against the defaulter as per the resolution mentioned above be initiated and is approved. Modified & updated list of defaulters will be displayed on the notice board and in Ankur M.C. what's app group on weekly basis and the list of defaulter will be referred to R.C.S for recovery of dues.

5. Resolved that the tenure of security agency " M/s. 4 Eyes security services Pvt. Ltd. is extended defacto till September 30<sup>th</sup> 2023. The services of present security agency is deliberated in the Management Committee and is not found satisfactory.

The Members present in the meeting discussed the incidents of theft in the society and suggested for termination of present security agency and appoint another security agency. As such the 2<sup>nd</sup> lowest agency in the quotations dated 09.01.2023, has been called and an agreement has to be drawn for its services.

#### 6. Improvement of C.C. T.V. Camera-

Due to theft cases in the society it was felt that the working condition of the camera was unsatisfactory and decision has been taken for repair / replace the cameras wiring conduct pipes etc. It has decided to call for quotation from experience person to install the cameras. However the work of repair/ replace the cameras has been started by the society staff in house. An amount of Rs. 1,00,000/- (Rupees one lacs only) is approved for the work. Some members in the society suggested to install TAG System for incoming and outgoing of the vehicle in the society " My gate or other similar companies may be invited to install the system.

Resolved that sub- committee of security will look into and finalize the work to be done. The members of the sub- committee are as under- (1) MsAnju Sharma (convener) (2) Mr. K.V. Mohann Raao (3) Mr. Kamal Singh Chauhan.

Progress of development works - progress of Development works in the society has been hampered due to show cause notice and or the order of the R.C.S Dated 14.06.2023. The work of main gate of the society is to be started, which is already in pipe line - A sub- committee to construct the gate has been constituted as under- (i) Mr. D.K. Nigam (Convener) (ii) Mrs. Vijay Laxmi Singh (iii) Mr. Mohan Chand Dhyani(iv) Mr. Anil Kumar, (vi) Mr. S.N.Behara.

Moreover the road of society has to be laid again for which the aid from M.L.A Fund is to be mobilized . The sub- committee for main gate will over look the road work.
