Receipt for December 2023 Rs. 11,76,176/-) Rupees eleven lacs seventy six thousand one hundred seventy six only) For January 2024 receipt Rs. 2,41,366/- (Rupees two lacs forty one thousand three hundred sixty six only), are confiremed and approved. Further resolved that Rs. 100/- (Rupees one hundred only) per person.has been collected from 313 members / residents of the society for collection of New Year is exfacto approved and receipt of collected money (Receipt No. 7087) has been issued . Members whose papers are not found complete, have already been informed and are requested to complete their paper at the earliest . While examming the application paper following anomalies have been found .

- Some members are seeking dual membership (second membership) (i) which is not allowed as per D.C.S act 2003 (Section 91)
- Some flat owners have mentioned area of allotted parking space in the (ii) sale deed of their flats as 10.00 M2 16.00 M2 area and have also paid stamp duty which is illegal . While allotting these parking spaces no mention of this area are in the order 1991 (G.B.M.1991), as it is only a facility for parking their vehicle . Resident / members should get their sale deed rectified at the earliest . A omplaint has already been sent to the revenue department. Moreover this issue has been mentioned in duly approved secretary report point No. (16) in the G.B.M. held on 24.10.2023.

## Report of sub-committee for civil works-: (4)Recommendations of sub- committee for civil works has been submitted to management committee are is under:

- Water softening plant ( estimated cost as 7.5.00 lacs ( Rupees seven (i). fifty thousand only) lacs
- Renovation of main Gate -: (Estimated cost is as 11.51 lacs (Rupees (ii). Eleven lacs fifty one thousand only )
- Installation of Rain Water Harvesting System in the society -: ( Balance (iii). work) Estimated cost of Rs. 10.00 Lacs (Rupees ten lakh only).

Resolved that the report of sub-committee for the above said three items with estimated cost is approved . A recurring cost for water softing plant is estimated within Rs. 20000/- (Rupees twenty thousand only)

#### Security services -(iv)

Further resolved that the tender / quotations of all four work, has been deliberated in the meeting and it has been decided that for transparency, the tender / quotations should be published in two news papers ( Hindi & English news papers).

- Tile works in side surface of overhead tanks-(V) A sample tile works inside the O.H.Tanks of flat No 211, 212, and 213 has been done. An approximate cost of tile work in each tank has been found within Rupees five thousand per tank.
- Paver block work- A sample of laying paver block(tile work)in front of (vi) society office, be done to assert the cost involved in the work.
