Nav Nirman Cooperative Group Housing Society Itd. under section 70 of Delhi Cooperative Societies Act 2003, The Honable Dy. Registrar of Cooperative Societies has reffered the case to the Arbitrator.

- illegal construction done by member :- Resolved that Mr. Adesh kumar 7. flat No. 139, membership No. 369, has done illegal constrction in the covered car parking space No. V-65. Three letter;s have already been issued to remove the illegal toilet and kitchen constructed in the covered car parking space. But so far he has not removed the above said construction . Beacuse of his adamant behaviour. The management committee hereby is forced to take further strict actions in the matter. Further resolved that further legal actions will be initiated.
- Letters from members :- Resolved that two letters have been received from 8. Mr. Adesh Kumar flat No. 139, in the society office on 07.03.2025. Further resolved that Mr. Adesh kumar is trying to derail and to stop the development works in the society. Mr. Adesh kumar is doing such acts regularly to defame the management committee and to create hurdles in the welfare work being done by the management committee.

Case of dual membership in the society:-Resolved that it is learnt from the reliable sources that Mr. Pawan Aggarwal flat No. 261, membership No. 439 has taken dual membership in adjoining aditi Apartments society which is a violation of section 91 of Delhi Cooperative Societies Act. 2003.

Further resolved a letter should be written to him regarding this violation and reply should be sought within 3 days of issue of this letter.

Show Cause Notice issued by Registrar of Cooperative Societies:-A Show casuse notice was issued to management committee by the (ii) Hon'ble Registrar of Cooperative Societies on 05.04.2023, stopping all welfare work in the society on the complaint of Mr. L.N. Dhawan (flat no. 150), Mr. Jai Prakash flat no. (151) Mr. N.K. Srivastava flat No.(170) Mrs. Madhulika Goel Flat No.(250) And Mr. R.K. Govil Flat No.(26) The Management committeea was forced to spent (Rs.101400/- (Rupees one lakh one thousand four hundred only) for presenting the case in Hon'ble High Court and in the Court of Hon'ble Registrar of Cooperative Societies in the case the Registrar of Cooperative Societies held many hearings in this case. Management t committee had lost two previous years, which could have been utilized for welfare works . In the order passed by the Hon'ble Registrar of Cooperative Societies which is reiteratedas under :-

> in view of the above maintained facts and circumstances, I am " cf the considered opinon that no ground are made out for superssion of the present manageing committee of the society under section 37, of Delhi Cooperative Societies Act. 2003, hence the proceeding initiated Vide show Cause Notice dated 05.04.2023 issued under section 37 (i) of Delhi Cooperative Societies Act 2003. **ARE HEARBY DROPPED "**

These previous complaints led to mental and physical tension to the Hony. Management committee members and the society members at large and also huge financial loss to the society funds. The matter has been delebrated in the management committee meetings and it has been decided to recorver the above said amount from these five complainants members immediately.
