M In the society office , after the conclusion of management committee meeting at 3.00 P.m , the dissent note was submitted with incorrect signatory and wrong claimant's name, Posing as Hony. Secretary with malafied intention .All the management committee member hereby are informed, as per rules Delhi Cooperative Societies Act 2003 & Delhi Cooperative Societies Rules 2007, under section 60(4), Please refer to your Dissent forwarded to Arbitrator by Mrs. Madhulika Goel on dated 30.06.2025, before putting up in the management committee which constitutes a breach of discipline and All the Management committee members hereby strongly condemned the act & disciplinary letter to be issued to Mr. L.N. Dhawan and Mrs. Madhulika Goel

Further more the management committee unanimously approved and confirmed the resolution.

**Case dated 30.06.2025 .**

The management committee is ready to pay only principle amount Rs. 72,000/- (Rupees seventy two thousand only) without interest and other claims on submission of I. Bond and valid payment proof. It is unanimously approved by voting 10 out of 11 voted members in favour , only one member disagreed

The voting procedure is in place. However this is now approved and confirmed by Management committee on dated 06.07.2025

**(6) Any other item with the permission of chair:-**

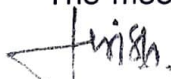
