Further resolved that Rs. 50,000/- (Rupees Fifty thousand only) is approved to celebrate the function.

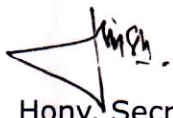
4. Civil & Repair Works: Following works will be taken up as per priority

- (iii) Tiles works in the underground tanks and O.H. tanks of the society.
